Having regard to Government memo cited under reference the colleges whose names enlisted /appended to the annexure of said memo are permitted to conduct spot & management quota admissions as per the schedule mentioned below:

Cut off date for submission of documents for verification along with NCTE approval letter	29.12.2017

Portal for entry of admissions made in online management system will be made available after 23.12.2017. Meanwhile the colleges permitted now are requested to intimate the mobile number . Managements are requested to submit the following along with documents.

1. Printed hard copy taken for from the portal for the admissions made.
2. Original affiliation letter granted from the affiliating University.
3. A consolidated demand draft towards processing fee collected from the candidates drawn in favour of Secretary APSCHE payable at Guntur (A single DD for both management and Spot).
4. Further,the managements are informed to upload the staff particulars in the portal of APSCHE on or before 20.12.2017 and submit the hard copy of the staff list uploaded along with the documents of spot & management quota admissions.
5. The information containing the details like, Name of the College, address with PIN, college code, mobile number, contact person, email id, affiliating university, NCTE permitted intake shall be communicated by mail typed on the college letter head to the address specialofficerapsche@gmail.com before 18.12.2017.
6. It is also informed that the candidates admitted now are not eligible for fee reimbursement.
