*It is hereby brought to the notice of all the concerned that Government issued orders in the following GO's for sanction of post-matric scholarships and reimbursement of Tuition fees & special fees for all the eligible students belonging to **BC/SC/ST/Minority communities /Differently abled students** admitted by the State Agency (category 'A' seats) at different levels in various Professional & Non Professional courses offered in Government/University and Private Unaided Minority/Non Minority Institutions in the State for the academic year 2008-09.*

2) *The eligible students claiming for Tuition fee & special fee reimbursement shall apply to the Principal of the Institution where they are studying in the format prescribed by the Department concerned before the cutoff date. The Principal of the Institution shall forward the applications duly authenticated with his signature and stamp of the Institution to the Authorities concerned.*

3) *The Managements are directed not to pressurize the eligible applicants for payment of Tuition fee for fresh as well as renewal of admissions in 2nd year onwards as the same will be reimbursed directly to the colleges by the concerned Department.*

4) *The Managements should prepare data of all the applicants **category wise** and submit a copy of the same in soft copy with a covering letter after certifying the authenticity of the data and duly affixing the signature of the Principal to all the concerned Departments, University as well as Secretary, A.P.State Council of Higher Education, Hyderabad*

5) *The Managements of the colleges concerned are requested to keep in view the above guidelines in processing the applications for Tuition fee & special fee reimbursement and submission of data to the authorities.*
